The meeting was preceded by committee meetings held on September 12-14, 2007.

An update was provided on the search underway for an Executive Director. JB Cordaro was acknowledged for his term as the interim Executive Director during this process.

The Board approved the motion that IBLCE will not accept pre-exam education hours or award CERPs for sessions conducted by individuals whose certificate has been suspended or revoked by IBLCE during the period of suspension or revocation. This policy will be published on the website and through the IBCLICK. In addition, issues involving the misuse of the IBCLC credential and/or trademark infringement by an IBLCE exam candidate shall be handled by the Ethics and Discipline Committee, the IBLCE Board of Directors, and Legal Counsel. Further revisions in the IBLCE Scope of Practice, to include incorporation of the Code of Ethics, are underway.

It was decided that IBLCE will begin the process of developing, implementing, and evaluating a breastfeeding support credential, to include appropriate funding with annual financial and programmatic review to determine long-term feasibility. The following statement was approved for posting on the website: "IBLCE continues the process of developing, implementing, and evaluating a breastfeeding support credential. As part of its vision, IBLCE actively pursues all opportunities to reach out to underserved communities to create a world where breastfeeding is the cultural norm."

A task force was appointed to discuss revision of the certification pathways. Approval was given to the University of California San Diego Lactation Consultant Program Academic Pathway F as a pilot project for 4 years, beginning with the 2007-2008 academic year. The Board indicated agreement with basic components of this program, which included course work being ILEAC accredited and clinical practice hours supervised by IBCLCs in at least three different practice settings. Certification outcomes of these candidates will be tracked and analyzed.

A report on the role delineation study was presented. Study results will be reviewed with the Psychometric Consultant and then posted on the website.

The Treasurer gave the financial report and reviewed the proposed budget for fiscal year 2008.

The MILCC Board Chair gave a report to the IBLCE Board. MILCC reported an increase in scholarship requests in 2007. The new Friends of MILCC pin was shown to the board. The JoAnne W. Scott Scholarship fund has continued to increase to \$18,992. The status of MILCC as a 501C3 of MILCC was confirmed. The MILCC By-Laws were amended to reflect Articles of Incorporation. The Board Silent Auction on September 14 yielded a \$1,000 donation to MILCC. Anne Andrianos will take over management of the MILCC website from Diana West, who has resigned from the MILCC Board. A letter of update will be provided to the family of JoAnne W. Scott on the JWS Scholarship Fund. The process of reviewing and awarding scholarships will be revised. New MILCC Directors for 2007-2008 include: Ellen McIntyre, Claire Dalidowitz, Anne Andrianos, Jim Akre, Roberta Hewat, Marcia Lutostanski, and Janet Fyle. MILCC Directors will conduct election to determine officers.

Current Board pictures are now posted on the website. Updating and archiving of information on the website was discussed. The privacy policy needs to be elaborated for the website. Production of the next IBCLICK was discussed. Consideration for electronic formatting for the IBCLICK will be discussed by the Regional Directors.

Governance Committee presented the Document Retention Policy as proposed by Legal Counsel. This was approved by the Board. It was decided that the Executive Summary will become the report that individual delegates forward to their respective organizations. The same would be true for reporting to other organizations of which IBLCE is a member. An amended IBLCE Statement of Policy Concerning Conflicts of Interest was approved, to be signed as the first order of business at each Board of Directors meeting.
